

Dear Fellow Citizens:

As Mayor of the City of Livingston, it is my pleasure to present the 2021 Annual Report to the Citizens which recaps important projects, events, and activities in the City.

Thanks to the excellent work by our financial department, we have once again received the Certificate of Achievement for Excellence in Financial reporting for the 2020 Annual Comprehensive Financial Report. This is the 33rd consecutive year the city has earned this prestigious national award. The city is financially sound and we have managed this without implementing an ad valorem tax. Our Code Enforcement department is still working on cleaning up junked vehicles and dilapidated buildings in an effort to make our city safer and nicer looking.

We have seen several new businesses come to town such as Chick-Fil-A, Starbucks Coffee, Blue Wave Car Wash and the Long Branch Steakhouse. Our downtown area is alive with new businesses locating in the heart of Main Street. Petalz started a trend of locating downtown and soon others such as Ruby Cattle Company and Happy Camper joined them. We are excited to watch our downtown area be rejuvenated with new businesses and pedestrian traffic. We have new apartments being built as well as a new Senior Living facility.

Livingston's Hometown Christmas 2021 was a huge success with an estimated 10,000 people lining Main Street to watch the lighted parade which had over 120 entries. The drive-thru Christmas light display at Pedigo park continues to grow as our parks department is always making new displays. Our Easter Eggstravaganza was also successful this year with 20,000 candy-filled eggs and over 200 prizes for children ages 8 and under. A bicycle drawing was held for children ages 9 to 12.

Our city staff provides excellent Customer Service while promoting the programs that are available in our city. I appreciate their hard and efficient work. We have many volunteers who serve along side our staff assisting with some of our events such as our Easter Eggstravaganza and Hometown Christmas. It is an honor for me to serve as your Mayor along with the City Council who serves tirelessly and without compensation. I am proud to live in Livingston, A Great Place to Call Home.

Mayor Judy Cochran and City Manager Bill Wiggins presented the State of the City of Livingston address at the Livingston-Polk County Chamber of Commerce quarterly membership luncheon held March 30th at Cho-Yeh Camp and Conference Center in Livingston.

The City Secretary furnished Certification of Unopposed Candidates confirming that Alderman Ray Luna, Alderman Elgin Davis and Alderman Clarke Evans were unopposed for election to office for the election to be held on May 1, 2021. Council approved Ordinance No. A-826 cancelling the May 1, 2021 General Election and declaring each unopposed candidate elected to office.

Council approved payment of annual dues in the amount of \$1,150.00 for membership in the Alliance for I-69 Texas.

At the April 13, 2021 Council meeting, Mayor Cochran presented Municipal Court Judge Gaffney Phillips with a Certificate of Appreciation

for her service to the City of Livingston as judge and accepted her notice of retirement. Council appointed Shelly Bush Sitton to serve as Municipal Court Judge for the remainder of the term vacated by Gaffney Phillips ending May 31, 2021. In May, Shelly Bush Sitton was appointed as Municipal Court Judge for the 2-year term ending May 31, 2023.

At the May 11, 2022 Council meeting, the City Secretary administered oaths of office and presented Certificates of Election to Alderman Elgin Davis and Alderman Clarke Evans. Alderman Alan Cook was nominated to serve as Mayor Pro-tem for the 2021-2022 term.

Alderman Elgin Davis was reappointed to serve on the Deep East Texas Council of Governments Board of Directors for the 2021-2022 term.

Dr. Elias Kanaan was reappointed as the City's Health Authority for the 2-year term ending July 1, 2023. Dr. Kanaan has served the citizens of Livingston since his first appointment in 2005.

Council approved the payment of \$4,200.00 as the City of Livingston's pro-rata share of the annual funding of the Brazos Transit District service.

Alderman Clarke Evans was reappointed to serve on the Board of Directors of the Sam Rayburn Municipal Power Agency for the 2021-2023 term.

On behalf of State Representative James White, Mayor Cochran presented House Resolution No. 119 to the Livingston 10-U All Star Baseball Team. Mayor Cochran commended the team members for their accomplishment of being the state champions of Texas and for their representation of the City of Livingston and the State of Texas in the Dixie Youth Baseball AAA World Series in Laurel, Mississippi.

At the December Council meeting, the final plat of Panda Express Subdivision Tract 1 was approved by Council.

# LIVINGSTON POLICE DEPARTMENT

The Livingston Police Department created the Livingston Community Resource Guide to provide a listing of services available to citizens. For example, when severe weather is expected, officers contact individuals to distribute this informational pamphlet and further explain the resources available in our community.

The Livingston Police Department celebrated National Public Safety Telecommunicators Week in April and expressed appreciation for the dedication and professionalism of the department's personnel.

Sergeant Kevin Blackburn presented seven graduating seniors with the Caran Coward Memorial Scholarship, each in the amount of \$2,000. The scholarship funds were raised by department employees and volunteers at the annual barbecue lunch.

Livingston Police Department officers and personnel participated in another great year of "Shop With A Cop" at the Livingston Walmart, an event to provide a Christmas shopping experience to local children. Special thanks to Store Manager Jonathan Montalvo, his staff at Walmart and generous sponsors for making this event possible and also to the law enforcement agencies who participate.

# LIVINGSTON VOLUNTEER FIRE DEPARTMENT

The Livingston Volunteer Fire Department provides Livingston and the surrounding area with fire prevention, fire protection, medical first responders, rescue operations and hazardous material responses. The Department covers 250 square miles of property in its initial response area. The Department also provides mutual aid to the other ten departments in Polk County.



In 2021, the Livingston Volunteer Fire Department responded to 638 calls for service, including 301 inside the City and 337 outside the City.

The City Council approved the renewal of the annual agreement with Polk County for firefighting services to be provided by the Livingston Volunteer Fire Department outside the City limits from October 1, 2021 through September 30, 2022, reflecting funding of \$49,296.62 by the County.

The Department hosted their second annual drive-thru Trunk or Treat on Sunday, October 31st at Fire Station #2 and gave out bags of candy and fire prevention materials.

The Department presented fire prevention and fire safety programs to approximately 2,500 students at schools throughout Polk County.

## ELECTRIC DEPARTMENT

Maintained lighting and electrical equipment at Livingston Municipal Complex, Livingston Municipal Airport, tennis courts, baseball fields, Livingston Municipal Library, Barney Wiggins Memorial Arena Fairgrounds, Matthews Street Park, LVFD fire training field and four LVFD fire stations. Maintained street lights, night lights and flood lights throughout the City.

Continued maintenance of rights-of-way throughout the City including mowing of vegetation, tree trimming and removal of dead or problem trees.

Performed routine maintenance of both Livingston and Ogletree electric substations.

Maintained 3,360 feet of LED lights that outline the buildings in the Main Street district during the holiday season.

At the October 12, 2021 Council meeting, the bid was awarded to Bright Star Solutions, LLC in the amount of \$232,015.47 for the S. Washington Feeder Rehab Phase I Project for the upgrade of the electric feeder to accommodate additional development in the area.

Assisted with installation of Christmas lighted displays in Pedigo Park and Anniversary Park.

Electric linemen participated in six safety meetings hosted by Texas Electric Cooperatives.

Installed seasonal Welcome to Livingston banners and military appreciation banners throughout the year.

Continued routine line maintenance including changing out of utility poles and anchors.



# PUBLIC WORKS DEPARTMENT

## WATER AND WASTEWATER DEPARTMENT

Maguire Iron, Inc. completed construction of the 150,000-gallon elevated water storage tank located at West Street and the 400,000-gallon elevated water storage tank located at Walnut Street and the tanks were put into service.

The final installation steps for the SCADA (Supervisory Control and Data Acquisition System) on sewer lift stations throughout the City were completed and the system was activated to allow remote monitoring and control.

Continued with fire hydrant maintenance and replacement throughout town.

Continued with upgrades to the water distribution system in various parts of town.

Continued sewer manhole rehabilitation on various manholes during the year.

## GARAGE DEPARTMENT

Maintained 36 generators that supply electricity to various city facilities during power outages.

Maintained and repaired more than 135 pieces of equipment/vehicles used by all city departments.

Maintained fuel supply for all departments and fuel operations at Livingston Municipal Airport.

Installed emergency lighting, radios and other equipment in new service vehicles.


## STREET DEPARTMENT

# SPECIAL EVENTS / TRADE DAYS / PARKS & RECREATION

Trade Days completed its 22nd year of operation. During 2021 the quarterly Trade Days event was held in March, May, October and November. The annual Spring Outdoor Expo was held in March.

The annual Kids Fishing Frenzie was held at Pedigo Park in October. The fishing tournament was a wonderful success. Thanks to generous sponsors, the pond was stocked with fish and a number of the fish were tagged for cash prizes. The City of Livingston joined with the Texas Game Warden Association and the following sponsors for the event: Direct Solutions, First National Bank, First State Bank, Sam Houston Electric, C&H Marine, McWilliams & Sons, Dr. Tiffany Jones Lee, Owen Furniture, Eastex Telephone, Best Air, Today's Dental, People's State Bank and Grease Monkey. The fishing tournament is for children from toddlers to 16 years old to promote an interest in fishing. Door prize drawings were held throughout the day. Goody bags, trophies and prizes were awarded.

The Polk County Garden Club hosted the 'Visit With Santa' event on Saturday, December 11th at Miss Effie's Cottage. Children delivered their letter to Santa's mailbox and took a photo with Santa. Packaged cookies and drinks were provided by the City of Livingston and handed out by Garden Club members.


Pedigo Park was an excellent outdoor venue for the 2nd Annual Livingston-Polk County Chamber of Commerce Smoke in the Pines BBQ Cookoff event. An auto and bike show and vendor booths added to the successful event.

The Livingston Youth Football Association, a competitive football league that plays in the East Texas Football Alliance, continued to meet at Pedigo Park during 2021. Players age 4 to age 12 learn and develop the fundamentals of football and teamwork.

The annual Easter Eggstravaganza returned to Pedigo Park with 20,000 candy-filled eggs and over 200 prizes for children ages 8 and under. A bicycle drawing was held for children ages 9 to 12.

Matthews Park Swimming Pool opened to the public on Memorial Day. Swimming lessons were held for over 495 children, including Water Babies, Water Waddles for 3-year-olds and regular swim lessons for children 4 years old and older. Matthews Park Swimming Pool is home to the Livingston Sea Lions swim team.

The Parks and Recreation Department created a wide array of special Christmas lighting throughout the City. The drive-thru Christmas light display at Pedigo Park and the First Baptist Church 'Drive Through Bethlehem' event were favorites of the Christmas season.



# LIVINGSTON MUNICIPAL LIBRARY



Livingston Municipal Library is located at the corner of Tyler and Milam Streets. The library was open on a limited basis through March when it reopened for regular business. The only change was that the library did not open on Saturday.

During 2021 a total of 16,657 customers entered the library. Livingston Municipal Library hosted 9 programs for children which were attending by 346 people.

The Friends of the Library continued to operate from their room on the second floor of the library. The Friends provided funds to purchase large print books, children's books, and the Houston Chronicle. They also contributed \$1,500 to allow the library to continue membership with the Piney Woods Digital Consortium, through which the library provides access to eBooks and downloadable audiobooks and movies. They provided funds for special programs and for the summer reading program.

# LIVINGSTON MAIN STREET

The Livingston Main Street Program envisions historic downtown Livingston as the heart of the City – a place where social, economic and civic activities generate a welcoming environment for local citizens and visitors to enjoy.

Livingston Main Street continues to help revitalize downtown Livingston. Main Street distributed \$21,982.50 in reimbursement grant funds to downtown business and building owners during 2021. This funding was raised by local efforts.

Members of the Main Street Advisory Board are Molly Anderson, Jeremy Buie, Kim Brown, Jessica Corwin, Julee Evans, Julie Mayes Hamrick, Joyce Knierim, Tammi Ogletree, and Whitney Roberts.

Main Street is a member of the Livingston Specialty Merchants Guild, an organization comprised of local, independent businesses who promote the Livingston area.

The City of Livingston and Livingston Main Street partnered with the Livingston Farmers Market Association for the Farmers Market in Anniversary Park from May to August.

Main Street partnered with Livingston Specialty Merchants Guild to organize the month-long Shop Local campaign running from October through November. Numerous local businesses participated with hundreds of participating customers.

Livingston Hometown Christmas 2021! Main Street joined with all City departments to host an estimated 10,000 people who visited the downtown area. The Jingle Bell Fun Run had a record number of participants at 349. Visits with Santa were held during the afternoon at Miss Effie's Cottage. Main Street organized the vendor spaces and provided space for the Livingston Quilt Club to display their creations. The lighted Christmas parade was the highlight of the year with over 120 entries.
