

## **RESOLUTION NO. 623**

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LIVINGSTON, TEXAS, EXTENDING FOR THIRTY DAYS THE DECLARATION OF LOCAL DISASTER ISSUED BY MAYORAL PROCLAMATION ON MAY 2, 2024 IN RESPONSE TO WIDESPREAD FLOODING**

**WHEREAS**, on May 2, 2024, JUDY B. COCHRAN, Mayor of the City of Livingston, Texas, issued a mayoral proclamation declaring a state of disaster for the City of Livingston, in response to the unusually heavy rainfall and resultant flooding during April 28-29 and May 1-2, 2024, which caused a significant and continuing imminent threat of disaster including widespread property and infrastructure damage, the potential for personal injuries and loss of life, high winds, severe thunderstorms, torrential rainfall, flooding, possible tornadic activity, electrical power and utility outages resulting from the effects of such weather events and other public calamities resulting therefrom, and

**WHEREAS**, the conditions necessitating such disaster declaration continue to exist; and

**WHEREAS**, the City Council of the City of Livingston, Texas has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property; and

**WHEREAS**, pursuant to §418.108(b), Texas Government Code, a local state of disaster may not be continued for a period in excess of seven (7) days without the consent of the governmental body of the political subdivision;


**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LIVINGSTON, TEXAS:**

**SECTION 1.** The Declaration of Disaster, which was signed and executed by Mayor Judy B. Cochran on May 2, 2024 shall be renewed and continued for a period of thirty (30) days from the date hereof unless further continued or renewed by action of the City Council of the City of Livingston, Texas, in accordance with §418.108(b) of the Texas Government Code.

**SECTION 2.** That this Declaration shall be filed promptly with the City Secretary, and shall be given prompt and general publicity pursuant to §418.108(c) of the Texas Government Code.

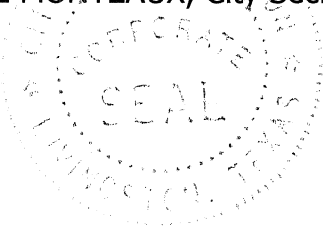
**SECTION 3.** It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public, and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551.

**DECLARATION OF LOCAL DISASTER  
FOR  
THE CITY OF LIVINGSTON, TEXAS**

**WHEREAS**, due to the extensive damage to public and private property, and disruption of public services caused by unusually heavy rainfall and resultant flooding during April 28-29 and May 1-2, 2024, which caused a significant and continuing imminent threat of disaster, including widespread property and infrastructure damage, the potential for personal injuries and loss of life, high winds, severe thunderstorms, torrential rainfall, flooding, possible tornadic activity, electrical power and utility outages resulting from the effects of such weather events and other public calamities resulting therefrom, all of which require emergency action; and,

**WHEREAS**, on April 29, 2024, Sydney Murphy as County Judge of the County of Polk, issued a Declaration of Disaster in Polk County, Texas; and

**WHEREAS**, the Mayor of the City of Livingston, Texas has determined that extraordinary measures must be taken to protect citizens and to protect or rehabilitate property:

**NOW THEREFORE, I, JUDY B. COCHRAN, AS MAYOR AND PRESIDING OFFICER OF THE CITY COUNCIL OF THE CITY OF LIVINGSTON, TEXAS, HEREBY PROCLAIMS, ORDERS AND DECLARES:**

**SECTION 1.** That a state of local disaster is declared for the City of Livingston, Texas pursuant to §418.108(a) of the Texas Government Code.

**SECTION 2.** That pursuant to §418.108(b) of the Texas Government Code, this Declaration of Local Disaster shall be in effect for seven days from this date unless earlier terminated or subsequently continued or renewed by consent of the City Council of the City of Livingston, Texas.

**SECTION 3.** That the City of Livingston's Emergency Management Plan should be activated, pursuant to §418.108(d) of the Texas Government Code.

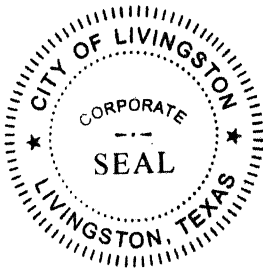
**SECTION 4.** That this Declaration activates the recovery and rehabilitation aspects of all applicable local or interjurisdictional emergency management plans and authorizes the furnishing of all aid and assistance as deemed necessary or desirable by those administering such plans, and activates the preparedness and response aspects of such plans as provided therein, pursuant to §418.108(d) of the Texas Government Code.

**SECTION 5.** That this Declaration shall be filed promptly with the City Secretary, and shall be given prompt and general publicity pursuant to §418.108(c) of the Texas Government Code.

**SECTION 6.** I authorize the use of all available City resources that are reasonably necessary to cope with this disaster.

**SECTION 7.** That this Declaration shall take effect immediately from and after its issuance.
