**REQUEST FOR RELEASE OF FUNDS**

On or about June 21, 2024, the City of Livingston (City) will submit a request to the Texas General Land Office for the release of Community Development Block Grant Mitigation (CDBG-MIT) Method of Distribution (MOD) funds appropriated under the Supplemental Appropriations for Disaster Relief Requirements Act, 2018 (Pub. L. 115-123), as amended, to undertake a project known as Street Improvements under GLO Contract #24-065-040-E532 to enhance ingress and egress from the area, particularly during natural disaster events.

**Project Description:**

Subrecipient shall remove and replace concrete pavement, install new water and sanitary sewer lines, improve driveway inlets and drainage, and complete associated appurtenances.

Potential objectors should contact the City via email to verify the actual last day of the objection period.

### **ENVIRONMENTAL CERTIFICATION**

The City of Livingston certifies to the Texas General Land Office that Judy B. Cochran, in her capacity as Mayor, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. The Texas General Land Office's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City to use Program funds.

### **OBJECTIONS TO RELEASE OF FUNDS**

The Texas General Land Office will accept objections to its release of funds and the City's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request, (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City; (b) the City has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by the Texas General Land Office; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality.
