A vendor commits an offense if the vendor knowingly violates Section 176.006, Local Government Code. An offense under this section is a misdemeanor.

Within the last 12 months, my company, Cook Land Surveying Ent., LLC, has been engaged by the City of Livingston to survey and described various easements and those projects are listed below :

1. South Washington Ave. corridor, namely on Cemetery Hill, to accomplish infrastructure improvements to the outermost areas of the City Limits.
2. Water Line easement within the Livingston Independent School District tract that was purchased from the old Texas Slam.
3. My company, Cook Land Surveying Ent., LLC, has served as a third party, or vendor, with regard to the drainage project within blocks 31 and 32 in the City of Livingston.

Those hours of ethical training have taught me to look out for potential conflicts of interest and it's those lessons that I've incorporated into my time as a City Alderman. It is my belief that because my company, which began in November of 1964 under the ownership of my uncle and father, has an immeasurable knowledge of this City and County, that we are able to provide the best service for any projects the City, or County, may require.

It was always my desire, as a City Alderman, to bring a knowledge of land boundaries and base of work to the residents of the City of Livingston to help with future development issues and opportunities.
