ELECTRIC RATES & FEES:

On September 9, 2025, Ordinance No. A-855 was approved by City Council and amended the electric rates and calculation of monthly utility bills to include the Power Cost Recovery Factor (PCRF). The PCRF is a charge that will fluctuate monthly to reflect the cost to the City of the wholesale cost of electricity.

Small Commercial	\$10.00 Customer Service Charge, Plus PCRF and Base Usage Rate of \$0.0350 per kilowatt hour
Residential	\$10.00 Customer Service Charge, Plus PCRF and Base Usage Rate of \$0.0360 per kilowatt hour
City Owned (ballfields, rodeo arena, etc.)	\$0.0980 per kWh

WATER RATES

Type of Service and Rates

Commercial Customers - Individually Metered

Includes any commercial building where each individual commercial unit or space is served by a separate water meter:

1. Up to and including 2,000 gallons per month - \$38.00 per month, plus
2. From 2,001 - 50,000 gallons - \$4.25 per thousand gallons per month
3. From 50,001 - 150,000 gallons - \$4.75 per thousand gallons per month
4. Over 150,000 gallons - \$5.25 per thousand gallons per month

Commercial Customers - Master Metered

Includes commercial buildings (other than those defined in Sec. (a)(1)(A) above as Commercial Customers - Individually Metered) where each separate commercial building is served by a single master water meter:

1. Each individual commercial or space, occupied or not, up to and including 2,000 gallons per month - \$38.00 per month, plus
2. From 2,001 - 50,000 gallons - \$4.25 per thousand gallons per month
3. From 50,001 - 150,000 gallons - \$4.75 per thousand gallons per month
4. Over 150,000 gallons - \$5.25 per thousand gallons per month
5. The person or entity named on the master metered account will be responsible for the payment to the City of all fees billed for the metered usage.

Residential Customers - Individually Metered

Includes single family residences, single family manufactured homes, duplexes, triplexes, townhomes and any other multi-family dwelling building where each individual family dwelling unit or space is served by a separate water meter:

- a. Up to and including 2,000 gallons per month - \$28.00 per month, plus
- b. Over 2,000 gallons per month - \$4.00 per thousand gallons per month

Residential Customers - Master Metered

Includes duplexes, triplexes, townhomes, apartment complexes, and any other multi-family dwelling buildings, and other hi-density residential dwelling buildings (other than those defined as Residential Customers - Individually Metered) where each separate multi-family building is served by a single master water meter:

- a. Each individual dwelling unit or space, occupied or not - \$20.00 per month, plus
- b. Each 1,000 gallons or portion thereof per month - \$4.00 per thousand gallons
- c. The person or entity named on the master metered account will be responsible for the payment to the City of all fees billed for the metered usage.

SEWER RATES

Type of Service and Rates

Commercial Customers - Individually Water Metered

Includes commercial customers where each individual commercial unit or space is served by a separate water meter:

- a. \$33.00 per month, plus
- b. \$4.00 per thousand gallons of water usage in excess of 2,000 gallons

Commercial Customers - Master Water Metered

Includes Commercial Buildings (other than those defined in Ordinance No. A-848 Section (3)(B)(1) as Commercial Customers - Individually Water Metered) where each separate commercial building is served by a single master water meter:

- a. Each commercial unit or space, occupied or not - \$33.00 per month, plus
- b. \$4.00 per thousand gallons of water usage in excess of 2,000 gallons
- c. The person or entity named on the master metered account will be responsible for the payment to the City of all fees billed for the metered usage.

Residential Customers - Individually Water Metered

Includes single family residences, single family manufactured homes, duplexes, triplexes, townhomes and any other multi-family dwelling building where each individual family dwelling unit or space is served by a separate water meter:

\$23.00 per month, plus \$1.50 per thousand gallons of water usage in excess of 2,000 gallons up to a monthly maximum charge of \$42.50 (15,000 gallon cap).

Residential Customers - Master Water Metered

Includes duplexes, triplexes, townhomes, apartment complexes, and any other multi-family dwelling buildings, and other hi-density residential dwelling buildings (other than those defined above as Residential Customers - Individually Water Metered) where each separate multi-family building is served by a single master water meter:

- (a) Each individual dwelling unit or space, occupied or not - \$20.00 per month, plus
- (b) Each 1,000 gallons or portion thereof per month - \$1.50 per thousand gallons of water usage up to a monthly maximum sewer charge of \$42.50 for each individual dwelling unit or space.
- (c) The person or entity named on the master metered account will be responsible for the payment to the City of all fees billed for the metered usage.

SANITATION SERVICE RATES

Residential Service Fees:

1. Fee for one 90-gallon plastic toter provided by the Contractor, once weekly, shall be **twenty-three dollars and fifty cents (\$23.50)** per month.
2. Fee for two 90-gallon plastic toters provided by the Contractor, once weekly, shall be **thirty-three dollars and fifty cents (\$33.50)** per month.

Each mobile/manufactured home shall be considered a separate residence. Also, each unit of an apartment complex is considered a separate residence.

Commercial Non-Containerized Service Fees:

1. Fee for one 90-gallon plastic toter provided by the Contractor, once weekly, shall be **twenty-three dollars and fifty cents (\$23.50)** per month.
2. Fee for two 90-gallon plastic toters provided by the Contractor, once weekly, shall be **thirty-three dollars and fifty cents (\$33.50)** per month.
