**POLK COUNTY, TEXAS
COVID-19 CASES, HOSPITALIZATIONS, AND COVID
VACCINE LOCATIONS**

In Polk County and all across the State of Texas, healthcare workers and public health officials are seeing a rise in COVID-19 cases and hospitalizations. According to the Angelina County & Cities Health District, Polk County's COVID cases have increased by 195 in the last 7 days with a total of 317 reported active cases at this time. According to the Angelina County & Cities Health District, Polk County has been averaging 25-30 NEW COVID cases a day for the past 3 weeks. CHI St. Luke's Memorial-Livingston reports that 11 COVID patients are hospitalized and 5 of those patients are in ICU.

Some hospitals in Texas are transferring COVID patients out-of-state to receive care due to hospital bed and staffing shortages.

According to CHI St. Luke's Memorial-Livingston, the current upswing in COVID cases is taxing their resources. The critical care staff is stretched which makes it vitally important that we all do our part and help reduce the spread of the virus.

According to the CDC, COVID vaccination helps avoid severe illness, hospitalization, and death. Unvaccinated individuals account for nearly all the hospitalizations and deaths in the country.


